Driven by rising farm mechanization, favorable monsoons, and rural financing, the Indian Tractor Market size is expected to grow from a value of USD 8.4 billion in 2025 and to reach a market value of USD 15.3 billion by 2034 at a CAGR of 7.0%. *Source: Dimension Market Resource*
